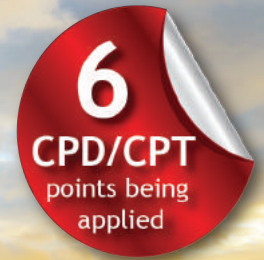

Vanina Sucharitkul, International Arbitrator

Ms Sucharitkul specializes in international arbitration and has experience advising local and international clients on a diverse range of cross-border disputes involving commercial contracts, investigations and anti-corruption, joint ventures, insurance and reinsurance, construction and infrastructure projects, environmental contamination and investment treaty arbitration in San Francisco, Paris, Bangkok, and Hong Kong. Ms Sucharitkul has experience acting as counsel and advocate in arbitrations across multiple jurisdictions under the auspices of institutions including, amongst others, ICC, HKIAC, SIAC, AAA, and TAI. Ms Sucharitkul has served as Thailand's Court Member to the International Court of Arbitration of the International Chamber of Commerce since July 2012 and is currently sitting as arbitrator in cases mostly involving construction disputes. Vanina is also a senior lecturer in the LL.M. program on the subject of international commercial and investment arbitration at L'Université Paris Descartes (Paris V) in Paris.

Prior to joining Herbert Smith Freehills between 2007-2017 in Bangkok, Paris and Hong Kong, Ms Sucharitkul developed her career as a litigation and arbitration associate at Morrison & Foerster in San Francisco, practicing a range of U.S. commercial litigation matters including securities, antitrust, trademark, and class action. She also has experience in international arbitration on issues of expropriation and public international law. Ms Sucharitkul completed her undergraduate studies at University of California at Berkeley and her Juris Doctor at University of California, Hastings College of the Law. She is currently completing her doctoral dissertation on the backlash against investment treaty arbitration and investor-State dispute settlement (ISDS) reform at the Université Panthéon-Assas (Paris 2).

A holder of three nationalities, Ms Sucharitkul speaks English, Thai, and French fluently. Ms Sucharitkul is a member of the California Bar, a fellow of the Chartered Institute of Arbitrators (FCIArb) (East Asia Branch and Thailand Branch Executive Committee), an Executive Board Member of ArbitralWomen, a listed arbitrator on the reserved list of the Singapore International Arbitration Center (SIAC) and the Thailand Arbitration Institute (TAI), a member of the ICC Commission on Arbitration & ADR, a fellow at the International Dispute Resolution Academy (IDRA) Hong Kong and a member of the Thailand Arbitration Center (THAC) Arbitrators Committee.

Dr. Derek Ritzmann, Expert, Economics Partners, Adjunct Associate Professor, Faculty of Law, University of Hong Kong

Dr. Derek Ritzmann is an Economic Expert at Economics Partners, working across the Asia-Pacific region based in Hong Kong. He is also an Adjunct Associate Professor at the University of Hong Kong, teaching competition law.

Dr. Ritzmann has been practicing as an economist for over 20 years, specializing in the economics of competition, regulation, and arbitration. He has served as expert on a wide range of matters, including many mergers, anti-competitive agreements, abuse of dominance, and economic regulation cases.

Dr. Ritzmann spent over a decade as a senior economist at competition and regulatory agencies and consequently has significant expertise in dealing with agencies on such matters. He was the first Chief Economist of the Hong Kong Competition Commission, served in the Chief Economist Team at the European Commission's Competition Directorate, and the Principal Economist (for both competition and telecommunications regulation) at the Australian Competition and Consumer Commission. Most recently, he headed the Asia-Pacific practice based in Hong Kong of a large economic consulting firm; previously, he worked in private practice as an economist at two leading consulting firms in Europe, and as a competition lawyer in Australia.

He is listed in the Who's Who Legal Directory as a Competition Economist and is a recent winner of a Concurrences Antitrust Writing Award. He holds a Ph.D. in Economics from Oxford University, an M.Sc. in Economics from the London School of Economics, and is a qualified lawyer in the USA, the UK, and Australia.

Joe Liu, Deputy Secretary-General, Hong Kong International Arbitration Centre

Joe Liu is Deputy Secretary-General of the Hong Kong International Arbitration Centre (HKIAC). He oversees dispute resolution proceedings under HKIAC's auspices, develops HKIAC's rules and procedures, and promotes HKIAC's services worldwide. He has acted as secretary to multiple tribunals in HKIAC-administered matters. Joe was a member of the HKIAC Rules Revision Committees which oversaw the drafting of both the 2013 and 2018 HKIAC Administered Arbitration Rules. He was also one of the key contributors to Moser & Bao, A Guide to the HKIAC Arbitration Rules - a detailed commentary to the 2013 Rules published by Oxford University Press. Joe is a frequent speaker and writer on issues of international dispute settlement.

Prior to joining HKIAC, Joe worked as a Registered Foreign Lawyer at Allen & Overy in Hong Kong and worked at the Singapore International Arbitration Centre. He is admitted to practice law in New York and a fluent speaker of English, Mandarin and Cantonese. He holds an LLB from Wuhan University and LLMs from the London School of Economics and Political Science and New York University.

Conor Quigley QC, Serle Court Chambers

Conor Quigley QC practices law from Serle Court Chambers, one of London's leading commercial barristers' chambers. He specializes in European Union law, in particular concerning competition, commercial, trade and tax law. Conor is widely regarded as the leading expert at the English Bar in the law of EU state aid and subsidies control. He is the author of the leading textbook, European State Aid Law and Policy, now in its 3rd edition (2015) and is also co-author and general editor (with Suzanne Rab) of Hong Kong Competition Law (2016), (both books available from www.hartpub.co.uk). He regularly advises UK governmental and public authorities, major multinational groups, and other interested parties, and has acted in some of the leading EU law cases over the last 30 years before the European Court of Justice, the UK Supreme Court and Court of Appeal and High Court.

Conor accepts appointment as arbitrator in international disputes, in particular concerning international trade, state aid and subsidies, competition law and environmental issues. He is listed in the Shanghai International Arbitration Centre and has been appointed an ad hoc sole arbitrator by IATA. In 1991 Conor became a member of the Law Faculty of the University of Oxford, when he was appointed a Fellow in EU Law at Lady Margaret Hall. Since 2008, he has been a Visiting Research Fellow at the Institute of European and Comparative Law. He has also held visiting posts at the College of Europe, King's College London and the International Tax Centre, Leiden University.

Moses W, Park, Barrister, Liberty Chambers

Moses W. Park is a dispute resolution lawyer practicing as a barrister (trial advocate) based in Hong Kong. His practice mainly focuses on conduct and resolution of cross-border and international commercial arbitration and litigation. He has successfully handled a broad spectrum of commercial work with an emphasis on civil fraud, asset-tracing/recovery, enforcement of foreign arbitral awards and judgments, securities and investment products as well as shareholder disputes. Moses' work extends to regulatory fields (providing advice on matters governed by securities and competition legislation) often involving a mix of private and public law elements. Gavin Denton, Arbitrator & Head of Chambers, Arbitration Chambers

Gavin specialises in commercial dispute resolution, with significant experience in international arbitrations across the Asia-Pacific region, including, Hong Kong, mainland China, Singapore, the Philippines, India and Australia. From 2009 to 2010 Gavin was based in Beijing where he undertook his Masters in Chinese law at Peking University, while also working as an arbitrator. Having completed his LL.M. In November 2010 Gavin relocated to Hong Kong to establish Arbitration Chambers. Gavin has sat in over 60 international arbitrations under the rules of the ICC, HKIAC, SIAC, KCAB, CIETAC and UNCITRAL. Gavin has sat in matters involving general commercial disputes, finance & shareholder disputes, shipping, international trade & sale of goods, IP and China-related disputes.

Catrina Lam, Barrister, Des Voeux Chambers

Catrina was called to the Bar in 1999 and enjoys a broad and robust civil practice covering a wide range of commercial disputes, as well as competition, securities and public law. Catrina has considerable experience in handling competition law matters. She has been advising and appearing in Competition Commission v Nutanix Hong Kong Ltd & Ors, the first case commenced before the Competition Tribunal after the Competition Ordinance came into effect in December 2015.

She has advised major telecommunication companies on licensing and competition issues. She appeared on behalf of PCCW-HKT in two of the first cases on competition law before the then Telecommunications (Competition Provisions) Appeal Board (led by Sir Peter Roth QC, currently The Hon Mr Justice Roth of the High Court of England and Wales and the President of the Competition Appeal Tribunal in the United Kingdom). She is on the Competition Commission's Panel of External Counsel and was recently appointed as a Non-Governmental Adviser to the International Competition Network. She is also a member of the Hong Kong Bar Association's Special Committee on Competition Law. In October 2016, she was selected by the HKBA as one of four counsel to undertake a secondment at Monckton Chambers, a leading London set specializing in competition law. She completed a Postgraduate Diploma in EU Competition Law at King's College London in 2017 and was ranked an Up and Coming Barrister in Chambers & Partners Asia Pacific 2018.

Steven Parker, Executive Director (Legal Services), Competition Commission (Hong Kong)

Mr. Steven Parker was appointed to the position of Executive Director (Legal Services) of the Competition Commission (Commission) in July 2017. Before his appointment to the Commission, Mr. Parker was the Chief Litigation Counsel of the Hong Kong Monetary Authority (HKMA). He joined the HKMA in 2003, first as a Senior Counsel in the Office of the General Counsel, and became Chief Litigation Counsel in 2013. Mr. Parker relocated to Hong Kong in 1994 and worked for private law firms until 2000, when he joined the Civil Litigation Unit of the Department of Justice as a Senior Government Counsel. Before coming to Hong Kong, he was in private practice in Canada.

Mr. Parker holds a Bachelor of Arts degree and a Bachelor of Laws degree from the University of Alberta. He was admitted as a Barrister and Solicitor in Alberta, Canada in 1987. He was then admitted as a Solicitor of the High Court of Hong Kong in 1996 and as a Solicitor of the Supreme Court (England and Wales) in 1998.

Elvira Aliende Rodriguez, Partner, Shearman & Sterling

Elvira Aliende Rodriguez is a partner in the Antitrust practice of Shearman & Sterling's Brussels office. She focuses on Spanish and EU competition law. Most recently at A&M, Mr. Williamson has been involved in: leading an investigation and financial restatement relating to a multi-billion dollar accounting fraud in the Asia operations of a listed European retailer; acting as a Compliance Monitor for a Chinese State-Owned-Enterprise; performing forensic accounting reviews of alleged fraudulent activity, corruption and accounting misstatements in China and across the Asia Pacific region; undertaking a global FCPA risk assessment and subsequent compliance audit; and leading an anti-money laundering review of a Macanese institution.

Mr. Williamson earned a bachelor's degree in Law from the University of Birmingham. He is a member of the Institute of Chartered Accountants in England and Wales and the Hong Kong Institute of Certified Public Accountants.

Adelaide Luke, Partner, Herbert Smith Freehills
