A firm Judicial Activists at his core, Joshua and his team of counsel has worked tirelessly to devise a number of novel applications which is aimed at pushing for the digital transformation of Hong Kong's judicial system.

Today, Joshua's practice is mainly focused in the field of dispute resolution and technology law.

Aside from his legal practice, Joshua is currently also a Senior Consultant with Prosynergy, a regulatory consulting firm which had been founded by ex-SFC Regulators as well as being a management consultant for the Korean Blockchain Centre.
