Dr. Anangga lectures at the Business and Management School, Bandung Institute of Technology, Bandung, and at the Law School, University Pelita Harapan, Jakarta.

He also regularly co-counsels with foreign lawyers on their Singapore-seated arbitrations and litigations. His varied publications include a piece in the Law Gazette published by the Law Society of Singapore, on how to maintain good and happy co-counsel relationships with foreign counsel.
